1. Certified copy of the Certificate of Incorporation/Registration of the Company
2. Certified Registration Certificate from the relevant authority i.e. NCA8 and above. The bidders should also furnish the names of specialist contractors whom they intend to engage as Domestic Sub-Contractors and who are duly registered with the National Construction Authority in Category NCA 8 and above and other relevant statutory bodies. Proof of registration must be provided.
3. Certified copy of KRA PIN Certificate, VAT Certificate.
4. Certified copy of KRA Tax Compliance Certificate.
5. Certified CR 12 valid for one year from the tender closing date.
6. Certified copies of National Identity cards (IDs)/ valid Passports for all Directors.
7. Contact address: Physical, Postal, Telephone and Email address of the Firm (Confidential Business).
8. Certified Audited Accounts for at least the last 1 year.
9. Properly filled Form of Tender.
10. Bidder **MUST** fill, sign and stamp the Integrity Declaration.
11. Duly filled Anti-corruption pledge form.
12. Proof of work of similar magnitude.
13. Bid Bond of 2% of tender sum, valid for 150 days from a reputable financial institution or PPOA approved insurance company as per format provided.
14. Proof of access to liquidated assets of not less than Kshs. 1 Million and this should be evidenced by:
 - A) Letter of line credit from approved financial institution specific to this project and indicating amount available of not less than Kshs. 1 Million, or
 - B) Overdraft facility from a commercial bank specifically for this project
15. Youths, Women and Persons With Disability (PWD) are encouraged to apply and **MUST** attach certified copies of Directors' IDs, issued by the NCPWD and their relevant Certified AGPO Certificate (applies to all bids).

Note:
